**Scope of testing**

The evaluation is based on the measurement of the standby demand and the travel demand of the lift system.

The standby demand was measured five minutes after the last trip was completed. The travel demand was determined for reference trips without loading and was multiplied by a load factor of 0.7.

The detailed test procedure is given in publication VDI 4707 Part 1 - Lifts Energy efficiency.


The valid period of this certificate is three years, if the specifications and operation conditions are not significantly changed.






